

Complete entries must be postmarked or received on or before the Closing Date or they are deemed Late Entries. Complete entries will be processed in the order received and will take precedence over incomplete entries if the event fills. Complete entries include (1) completed entry form and release with signatures, (2) proof of negative Coggins within 12 months, and (3) check payable to FVSA. Late Entries will be accepted only at the discretion of the Show Secretary and if space is available. Late Entries will be charged a late fee of \$10 per class.

NO REFUNDS AFTER THE CLOSING DATE.

Riders who desire to bring a non-compete horse, *for schooling only*, must complete an entry form and release, provide proof of negative Coggins, and pay the office fee and stabling fee to FVSA.

Dressage Tests

Classes will be split into separate Adult Amateur and Junior/Young Rider Divisions. Open Division riders will be pinned separately. Please clearly indicate your Division on your entries. Tests will be run in 2 rings. Tests may not be scheduled in the listed order. Ride times will be available prior to the show.

- · USEF, USDF, USEA, and IDCTA Schooling Show rules apply.
- · Proper attire required. Show attire optional.
- Ribbons to 6th place. Adult Amateur and Junior/Young Rider Champion and Reserve for GAG/Intro and Training/First.
- · Show will take place rain or shine.
- · Food concession on grounds.
- · No alcoholic beverages allowed.
- Dogs are allowed but must be on a leash at all times and are not allowed in the Club House.
- FVSA is not responsible for any theft, accident, or bodily injury.
- FVSA reserves the right to require stall rental if weather conditions preclude parking on the grass.

- Fees (stalls include 1 bag of shavings)
- \$20 per dressage test
- \$10 late fee per dressage test for Late Entries
- \$15 office fee per horse/rider
- \$39 per overnight stall (available 3 p.m. Saturday)
- \$29 per day stall (available Sunday)
- \$15 tack stall (no shavings)
- \$20 haul-in fee per horse if not renting stall
- \$9 per each additional bag of shavings
- \$23 camper electric hookup Saturday & Sunday
- \$15 camper electric hookup Sunday only
- \$35 NSF check fee
